   We need a volunteer to host this year's event. If interested, email peter.dilworth@sympatico.ca.





Did you know: The Long Lake sill dam was originally constructed in 1895 as part of the Trent Canal system. It was rebuilt in concrete in 1921, and then again in 1939. Until 1950, the head water lakes (e.g., Long and Miskwabi) were indiscriminately drained to help make water levels in the lower part of the system navigable. In the late 1950's, there was a demand for more equitable distribution of water. Various lake associations in the area agreed that the "equal percentage of storage" basis should be adopted. This practice is still used today.



# One malfunctioning septic tank can tip the balance of lake phosphorus levels and cause a blue-green algal bloom.

# Haliburton County's Climate Change Engagement Survey

#### Let Your Voice be Heard

The first public engagement for the County's Community Climate Action Plan is now live!

Your input will help to determine what issues related to climate change are important to our community, and will set the stage for developing a plan that focuses on local priorities and creates local benefits.

New actions to reduce the impacts of climate change will promote sustainability and increase our ability to cope with a changing climate.

## 60% of Septic Systems Inspected on Wenona Lake had High or Medium Risk Issues

Last summer the Municipality coordinated the inspection of close to 100 septic systems on Wenona lake. 60% of the inspected systems had either a medium risk (i.e., pump out required, exposed outhouse earth pit privy, trees/vegetation/structures too close to weeping bed) or high risk (i.e., failing tanks or weeping bed, septics violating use permit, and grey-water discharge to ground) issue identified. The Municipality is carefully tracking the resolution of all these issues.

An adequately functioning septic system is extremely important to the health of our lakes. Phosphorus and other nutrients leaching from improperly functioning septics is one of the leading causes of Blue Green Algae. If you suspect your septic system is not working properly, MACA encourages you to get it fixed as fast as possible. #### **Haliburton County News**

#### **Shoreline Preservation By-law**

County Council will push the approval of the Shoreline Preservation By-law to the next council. However, they did vote to allow the county to move forward with a plan to recruit "a monitoring and bylaw enforcement" team and to write a proposal for a "lake health" program involving local organizations to review other water-related bylaws within the county and release information to the public.

#### **Short-Term Rentals**

The County is also reviewing issues associated with short-term rental accommodations. This is one of the fastest growing sectors in the sharing economy. There are many perspectives on home sharing some are in favour, while others are not.

The County has engaged J.L. Richards & Associates Ltd. to review the literature on short-term rentals, conduct an environmental scan of municipal practices, and consult with residents and stakeholders to understand their perspectives on issues related to short-term rentals. The next step is to provide a report to County Council focused on identifying solutions to address the community's concerns with short-term rental accommodations in the County.

# **Expanded Water Quality Testing**

Some members of the MACA executive have been working with Woodlands and Waterways EcoWatch (WWEW) and others to develop a plan for more rigorous lake water quality testing.

In order to develop protocols that meet the needs of local lake associations we have planned a Haliburton Water Quality Summit. It will be held in mid-June. At this summit current water quality testing initiatives and programs that already take place on our lakes will be discussed, and with the help of water quality and limnology experts, we aim to expand testing to better understand trends

in lake health data. This might include testing dissolved oxygen levels as well as studying lake bottom sediment for concentration of total phosphorus and other contaminants.

In addition, the MACA board has approved the additional expenditures required to participate in an expanded water testing pilot this summer along with 10 other Lake Associations. The objective of this pilot is to start developing standard testing protocols and to deliver ongoing water quality testing. As citizen scientists, our goal is to better understand the health of our lakes and thereby devise ways to improve or maintain water quality levels.

# New Invasive Species Prevention Signage at our Boat Launches

We are in the process of installing new signs at our boat launches to help protect our lakes from invasive species. These signs are courtesy of FOCA.

Please take care to make sure your boat is CLEAN, DRAINED and DRY before launching into any of our lakes. Once an invasive species is introduced into an environment, it's practically impossible to get rid of it.

Please don't be the one to introduce an invasive species to our lakes.

#### Benthic Invertebrate Testing



Last fall MACA marked its second year of participation in benthic invertebrate sampling as part of the Woodlands and Waterways EcoWatch Program (WWEWP) under the U-Links Centre for Community Research.

This program aims to establish a baseline of both the variety of species and the quantity of benthic invertebrates (bottom dwelling aquatic larval stage of insects), which can then be tracked over time as a scientifically demonstrated measure of the ongoing health of our lakes. Certain species are more sensitive to water quality measures such as dissolved oxygen, Ph, and other pollutants, so their absence or presence provides useful insight into water quality.

Some good news, these second year results showed an improvement in pollution and diversity measurements, with Miskwabi Lake having the highest diversity, and Wenona Lake having the lowest diversity. Climate, vegetation, sediment, and land use all contribute to the benthic composition of the lake.



#### Angler's Corner

Spring is here and what better way to get out on the water than to go fishing in our beautiful lakes! Fishing provides a great opportunity for young and old to share special moments together enjoying the great outdoors.

This is also a good time to remind our members and their guests that there are fishing regulations that apply in Ontario. For reference, we are in Fishery Management Zone (FMZ) 15. Detailed fishing regulations are available on-line at: <a href="https://www.ontario.ca/document/ontario-fishing-regulations-summary">https://www.ontario.ca/document/ontario-fishing-regulations-summary</a>.

Residents require two documents to legally fish in Ontario - your Outdoors Card and a Fishing Licence - either Conservation (lower catch limits) or Sport (higher catch limits). You can obtain these online or at a Service Ontario location for a small fee.

You do not need an Outdoors Card/ Fishing Licence if you:

- are under 18 or 65 years of age or older;
- have an Ontario issued Accessible parking permit;
- have a CNIB National Identification card; or
- are an active member or veteran of the Canadian Armed Forces.

You have to carry your valid government issued I.D. and one of the above. Conservation Fishing catch

limits apply unless you chose to buy an Outdoors Card/Sport Fishing licence.

4 times a year Ontario offers free fishing without a licence - Conservation limits apply. In 2022 these are:

- Family Fishing weekend (Feb 19-21)
- Mother's Day weekend (May 7/8)
- Father's Day weekend (June 18/19)
- Ontario Family Fishing week (July 2-10)

FMZ 15 open season dates and catch/possession limits (Sport/Conservation) for common fish in our lakes:


- Largemouth/Smallmouth Bass combined: fourth Saturday in June (25th in 2022) to Nov 30 - Limits: S-6 and C-2
- Lake Trout: January 1 to Sept 30 Limits: S-2 and C-1
- Northern Pike: January 1 to Mar 31 and third Saturday in May (21st in 2022) to Dec 31 - Limits: S-6 and C-2
- Rainbow Trout: open all year Limits: S-5 and C-2
- Yellow Perch: open all year Limits: S-50 and C-25

Finally, an important reminder to everyone who launches a powerboat/kayak/canoe into one of our lakes after having visited elsewhere. We all need to do our part to reduce the risk of invasive species entering our lakes. Please wash your boat, drain bilge and live wells, and let it sit (ideally in the hot dry weather) for a couple of days before re-entering our lakes. And never bring live bait or dump bait buckets into our lakes.

#### **Nellie's Oatmeal Cookies**

(Melt in your Mouth cookies)

#### **Ingredients**

- 1 cup shortening or margarine or butter
- ½ cup packed brown sugar
- 1 teaspoon baking soda dissolved in 1 teaspoon of boiling water
- 1 cup flour
- 2 cups rolled oats
- ¼ teaspoon salt
- 1 teaspoon vanilla
- 1 cup chocolate chips or more as desired (optional)

#### **Directions**

- Preheat oven to 350F
- Cream together shortening, sugar and vanilla
- Add soda mixture
- Mix flour, oats, and salt together and add to sugar mixture
- Blend together and roll into small balls
- Place on lightly greased cookie sheet
- Flatten each ball with a fork (use a sugar coated fork if desired)
- Bake 10-12 minutes in a 350F oven
- Enjoy

#### **MACA FLASHBACK! 36 YEARS AGO**

Here's what was making news in the MACA Newsletter of Spring 1986



In our Memory Lane piece we'll look at some of the interesting items in the Spring newsletter of 1986. Starting with....

The MNR at the time, was reviewing plans to close Lake Trout fishing on around 25 lakes throughout the Algonquin region over the winter months in an effort to curb over harvesting.

It was also at this time that the MNR proposed a requirement to have anglers obtain a Fishing License commencing in 1987. Anyone 18 and over wanting to fish was required to pay a \$10.00 fee per year and those 65 and older got a break and only paid \$5.00. [We are about to see something similar very shortly with the proposal to enact a 5 year renewal of pleasure craft licensing].

Development of cottage properties continued to be a challenge for developers in and around our lakes and a parcel of land made up of 49 lots changed hands for a 2nd time, in turn resurrecting the entire cycle of approvals and Plan of Subdivisions submissions in turn allowing for additional cottages to be built on Miskwabi.

There was also a piece about the Taxation & Financing of the Elementary and Secondary Education system in Ontario. The proposals and reports were asking the Ontario Government to take into account that cottages should not be taxed at the full mill rate. And unfortunately, we all know where that went! Alas we have a top-notch education system as a result.

And finally, the last item of interest at the time was a number of requests to have a dock installed at the Miskwabi Boat launch. Seems there was lots of discussions with the Municipality, various Insurance companies and with all the complexities, costs, and liabilities involved it turned into a bit of a challenge. It was turned over to the Municipality to determine the action plan going forward and unfortunately it was turned down due to the costs involved.
