

President's Message

As I write this, it is May 4th and there is still ice on Miskwabi Lake! This is the latest I can remember ice on Miskwabi dating back to the late 1990's – but I'm sure there may be folks who remember even later ice-outs – or perhaps unusually early ones. Have you kept any notes on "ice in/ice out" dates on your lake



A sure sign of spring is the return of the loons; on Miskwabi Lake they have already occupied the floating nest at the east end of the Lake, and pairs will likely be nesting on the other lakes soon (if they haven't already). If you are out on the water, a reminder to **please stay well away from the loons if you see them near their nests.** Startling them may cause them to abandon their eggs.

OUT WITH A BANG

Dysart Introduces New Bylaw Restricting Fireworks

On April 23rd, Dysart council voted unanimously to adopt a new fireworks bylaw.

The new bylaw will prohibit the use of fireworks, except on New Year's Eve, and the weekends of Victoria Day, Canada Day and the August Civic Holiday.

For years, MACA has been asking the Municipality to impose stricter regulations on fireworks.



When property owners were surveyed for the *Miskwabi Area Watershed Plan* in 2012, almost 80% of respondents identified "night skies" and "peace and quiet" as either "important" or "very important". Nearly 100% said "forest fire prevention" was "important" or "very Important".

In addition to causing noise, fire hazards, and harm to wildlife, fireworks pollute lakes and air with sulfur-coal compounds, heavy metals and other toxic chemicals including ozone, sulfur dioxide and nitric oxide.

The new law will also ban so-called "Chinese lanterns" – flying paper balloons with flames – which are an extreme fire hazard and have been banned in many other areas including parts of the US, Australia and Europe. One such "Chinese lantern" caused the worst-ever fire in the British Midlands, causing over \$10 million (6 million UK Pounds) in damage.

In a letter to Dysart councillors on March 8th, MACA again called for strict regulation of fireworks, and a total ban on the use of "Chinese lanterns".

MACA is pleased that Dysart has taken action on this issue, and will support the bylaw through education and signage where appropriate.

County Considers Development Charges

Haliburton County is looking into the possibility of introducing "development charges".

Development charges are typically one-time fees charged to land owners, developers, or



home builders when they build or develop land.

The fees are intended to help offset the costs to Municipalities resulting from increased development and population growth.

Haliburton is one of the few remaining areas in Ontario that does not impose any development charges.

The fees could potentially be collected at the upper-tier (County) or lower-tier (Municipal) level.

The first step in the process is to conduct a study, which will be done this year. After that there will be a consultation process, including mandatory public meetings.

Shoreline Protection Bylaw to be Expanded

Haliburton County's Shoreline protection bylaw is being revised and strengthened.

The existing Shoreline Tree Preservation Bylaw was introduced in 2012.



in "shoreline areas", which are defined as anywhere within 30 metres (approximately 100 feet) of the high water mark.

The proposed new bylaw would incorporate the existing bylaw, but also protect native plant species within the 30 metre shoreline zone. It would also regulate site alteration within the shoreline area.

Existing structures within 30 metres of shore could still be altered, but owners would be required to ensure that any development does not disrupt shorelines.

The County will ask for input on the proposed bylaw from Dysart and the other lower-tier Municipalities.

We would like to gather data on the "ice in and ice out" data for our lakes. I am sure that some of you may do this already and as such I am asking if you have any data to please forward to me at <u>jthagarty@bell.net</u> so I may populate our database.

The Love Your Lakes program is publishing a document with the data (and more!) for all the lakes they tested. Each lake tester will receive a copy and we will have a few at the Board. We will have copies for review at our Annual meeting in July. This document will be available for purchase and we will let you know the details as soon as we receive them.

The new signs are up at the Wenona and Miskwabi boat launching sites. We were the first to work with the Municipality on these signs and think the result was worth the effort. We hope that they will be effective in encouraging boaters to "do the right thing".

The importance of healthy shorelines is ever-important, so please ensure that your shoreline supports a healthy lake, and we do have brochures that could be passed on to those who may need a hint. If you would like some, please contact me or there will be copies at the AGM. The county and municipality are on board and are looking at shoreline bylaws to give us all some punch.

There have been complaints about geese on our lakes, they are not very tidy! The best way to make sure that geese do not intrude on your property....do not invite them! An open shoreline, grass cut to waters edge, is an open invitation for them. If you have a healthy shoreline as we encourage, the geese will go elsewhere. Have a great and healthy summer.

NATURE NOTES: "Natural" Isn't Just For Shorelines

One of the best ways we can help keep our ecosystem healthy is by "rewilding" our landscapes. We understand that natural shorelines are necessary to keep our lakes healthy but we also need to think about how our landscapes are supporting our birds, our pollinators and other critters who live here. Lawns don't support life.

Native plants have deeper root systems, stabilize the soil, absorb more nutrients and moisture and are more tolerant of extremes of climate. They also provide food and habitat for living creatures. "Messy is best" when it comes to supporting our ecosystem.



Leaving fallen leaves, re-naturalizing areas of your property by planting more trees and shrubs or by just letting your grass grow long and letting nature reclaim it is the best way to support our ecosystem. - Susan Hay

Cottage Cook's Corner

Favourite Recipes Shared by MACA Members



MAPLE BOURBON PUMPKIN SEED BRITTLE

Herald the arrival of spring by using delicious local Haliburton maple syrup in your recipes. This rich and buttery brittle is gluten-free and nut-free. A candy thermometer makes it easy to prepare.

INGREDIENTS:

- 1 cup sugar
- 1/2 cup local Haliburton maple syrup
- 1/4 cup bourbon
- 1/4 cup butter
- 1 cup pumpkin seeds
- 1/2 tsp baking soda
- 1/4 tsp salt

INSTRUCTIONS:

- 1. Line a baking sheet with parchment.
- 2. In a large saucepan, heat sugar, maple syrup, bourbon and butter over medium heat, stirring to combine, until mixture comes to a boil.
- 3. Attach a candy thermometer and continue to cook without stirring, until mixture reaches 300°F, approx. 20-30 minutes. Trust your candy thermometer, and watch the temperature when it gets close to 300°F - it can burn quickly. Turn off heat and quickly stir in pumpkin seeds, baking soda and salt. Pour onto prepared baking sheet and spread evenly. Be careful – mixture will be very hot.
- 4. Cool until hardened and break into pieces.
- 5. Store in an airtight container.
